AUTHORIZING AN INTERMUNICIPAL AGREEMENT WITH THE CITY OF SYRACUSE FOR ADMINISTRATION OF THE CITY OF SYRACUSE'S AMERICAN RESCUE PLAN ACT FUNDS TO HELP EXPAND THE POPULATION SERVED THROUGH THE ONONDAGA COUNTY EMERGENCY RENTAL ASSISTANCE PROGRAM (OCERA)

WHEREAS, the County has a mission to prevent the risk of homelessness, and understands that the COVID-19 pandemic and its attendant economic impact has affected the housing security of County residents; and

WHEREAS, the City of Syracuse ("City") has been granted American Rescue Plan Act Funds to help address negative economic impacts brought on by the COVID-19 pandemic; which include economic harms to workers, families, small businesses, impact industries, and the public sector; and

WHEREAS, the Onondaga County Department of Social Services – Economic Security is the appropriate agency to assess individual and family needs in the City, that are intended to be addressed by the funding received by the City from the U.S. Department of the Treasury, American Rescue Plan Act funds for Emergency Rental Assistance Programs; and

WHEREAS, the County and the City have determined that entering into an inter-municipal agreement is the most efficient method for meeting the needs of the above-described mission; and

WHEREAS, American Rescue Plan Act funds will support additional emergency rental assistance and homelessness prevention activities to mitigate the impacts of COVID-19. The County will use these funds to aid individuals and families with back rent, utilities owed, and in some cases future rents. To be eligible an individual in the household must have had a reduction of income or other financial hardship due to COVID-19; or an individual within the household can demonstrate a risk of experiencing homelessness or housing instability; there is an obligation to pay rental arrears and rent; and/or your household income is at 81% to 100% of the area's median income and the tenant is a City resident; and

WHEREAS, the City's American Rescue Plan Act funds in the amount of \$1,000,000 will be used to respond to the coronavirus pandemic (COVID-19) among City individuals and families who need urgent rental assistance and homeless prevention financial assistance to mitigate the impacts of COVID-19; and

WHEREAS, the County has agreed to act as the sub-recipient for the grant, and assign staff and advance benefits in performance of the grant; and

WHEREAS, the County will be reimbursed by the City, through the City's American Rescue Plan Act funding, for County expenses incurred to perform the program mission, including an allocation for administrative expenses; now, therefore be it

RESOLVED, that the County Executive is hereby authorized to enter into an agreement with the City to administer the grant program, and incur expenses which will be subject to reimbursement from the City's American Rescue Plan Act funding; and, be it further

RESOLVED, that the County Executive is hereby authorized to execute documents to further the intent of this Resolution; and, be it further

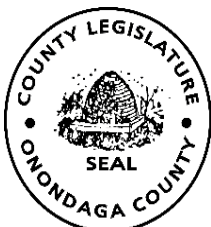

RESOLUTION NO. 93

AUTHORIZING AN INTERMUNICIPAL AGREEMENT WITH THE CITY OF SYRACUSE FOR REIMBURSEMENT OF CRIMINAL JUSTICE DISCOVERY REFORM GRANT FUNDING

WHEREAS, on April 1, 2019, New York State Legislature passed sweeping Criminal Justice Reform Legislation, Advancing Criminal Justice for All, by implementing Bail Reform, Discovery Reform, and Speedy Trial Reform; specifically, Discovery Reform repealed and replaced Article 240 of the Criminal Procedure Law and replaced it with Article 245 of the Criminal Procedure Law; and

WHEREAS, the Discovery Reform Law went into effect January 1, 2020 and mandates that the Prosecution in New York State to turn over 21 different kinds of discovery material to the defense, which includes all 911 calls, electronic recordings, name and contact information of any and all persons having relevant information, all statements by any person, name and information of all law enforcement personnel involved in the case, and rewards, promises or inducements offered to prosecution witnesses. The Prosecution's failure or inability to comply with these automatic and expedited discovery demands may have the potential to have the charges dismissed; and

WHEREAS, the Discovery Reform Law also mandates that the Onondaga County District Attorney's Office rely heavily on its legal and administrative staff, the Onondaga County Sheriff's Office, City of Syracuse Police Department and all local police agencies, 911 Emergency Department, Medical Examiner's Office, and local area hospitals, and imposed exorbitant budgetary demands on the Onondaga County District Attorney's Office, City of Syracuse Police Department and all local police agencies, along with the local agencies they works with, by imposing increased personnel, administrative, and technical costs; and

WHEREAS, the New York State Division of Criminal Justice Services (DCJS) has recognized these increased costs in implementing the Discovery Reform Law and has provided funding to the County to help with expenses related to the implementation of discovery and bail reforms; and

WHEREAS, the County of Onondaga agreed to receive grant monies, assign staff, and advance benefits in performance of the grant; and now seeks to reimburse the City of Syracuse through the Criminal Justice Discovery Reform Grant funding for the City of Syracuse's expenses totaling \$265,695, incurred in complying with the Discovery Reform Law, including an allocation for administrative expenses; now, therefore be it

RESOLVED, that the County Executive is hereby authorized to enter into an agreement with the City of Syracuse to reimburse them with grant monies received in the amount of \$265,695, for the costs associated with implementing the Discovery Reform Law; and, be it further

RESOLVED, that the County Executive is hereby authorized to execute documents to further the intent of this Resolution.
